PICK A TEST THEN CHOOSE A HEIGHT OF SJ TO SUIT YOU
INTRO, PRELIM & NOVICE Tests
SJ – 40 / 50 / 60 / 70 / 80 / 90cms

CLASS 1 - **Pony Club D Level** (walk & trot) 2012 & jumping @ **25cm**
There are no restrictions on tack for the dressage phase. Lead rein and assistance may be given in dressage and/or jumping phase. Test may be downloaded from pcuk.org/sport/dressage

CLASS 2 - Intro B (2009)	Show jumping height 40cm or PYO
CLASS 3 - Prelim 7 [2002]	Show jumping height 50cm or PYO
CLASS 4 - Prelim 14 (2006)	Show jumping height 60cm or PYO
CLASS 5 - Novice 24 (2010)	Show jumping height 70cm or PYO

Competitor rides their dressage test then they do a round of show jumping. Any faults in the jumping section are added to their dressage score to provide a final penalties score. In the event of an equal placing the quicker show jumping time will decide the higher placing.

*Classes 2-5: Jumping **above** the stated class height will lower penalty points [-2 per 10cm] whereas jumping **below** class height will gain penalty points [+2 per 10cm]*

CLASSES WILL RUN IN SCHEDULE ORDER

Initially, as this is a trial event, only one entry per rider/horse will be accepted. Additional entries will go on a wait list.

DRESSAGE WILL BE HELD ON SURFACED ARENA AND SHOWJUMPING ON GRASS

Clear Round

There will be allocated times during the day for clear round entries in the second jumping ring – numbers will be limited. £5/round – entries on the day.
